Global Executive MBA Programme Expenses

NEOMA Business School Global Executive MBA 2019-2020 tuition is €41,500 ex VAT, payable in three instalments.

This tuition fee provides for all academic related activity and academic materials such as some textbooks, copies and printing. For those working in France with a *Compte Personnel de Formation*, the code is 248958

Included in the tuition fee:

- Accommodation and lunch during the four different week-long International Learning Experiences in Accra // Bangalore // London // New York City.
- All expenses including transport to and from, accommodation and food during the three-day leadership boot camp on the French Navy Seal Base in Lorient, Brittany.
- Accommodation and food at the Integration Seminar.

Not covered by the tuition fee:

- Accommodation, transport to-and-from and food on campus in Paris, Reims or Rouen
- Transport to and from the International Learning Experiences
- Transport to and from the Induction Module
- Xmind Pro Mindmapping Software €80
- Visa to gain access to France, India, Ghana, UK and Visa or ESTA to gain access to the USA
- Books

Estimated additional expenses:

- Books may range between €50 to €500 over the duration of your Global Executive MBA, depending on personal choices to buy new or used, with Kindle or read for free on the NEOMA online library.
- Accommodation

Scholarship Eligibility & Rules

- 1) Candidate must be admitted into the NEOMA Global Executive MBA in order to apply for a scholarship.
- 2) Candidate may apply for up to two scholarships, but can only be awarded one.
- 3) Scholarship award may be combined with NEOMA Business School Financial Support.
- 4) Applicant must submit the completed Scholarship Application Package in PDF Format via email to the Global Executive MBA Admissions Department at emba.admissions@neoma-bs.fr including:
 - a) Completed Signed Scholarship Application Form
 - b) For each Scholarship, to submit the relevant Scholarship Application Essay. Your essay should be concise and we recommend that you do not exceed 500 words.
 - c) Completed Financial Planning form and relevant documentation.

The scholarship committee meets once a month. Scholarships are only applicable to personal financing of tuition fees, and are not transferable to corporate or other financing methods.

Early Bird Discount

An early bird rate of €4,000 ex VAT reduction in fees is available to all candidates who are admitted, confirmed their place **and paid their €5,000 deposit before April 15th for the summer intake and June 15th for the autumn intake**. The early bird may be combined with Scholarship and/or Financial Support. Any amount of the programme fees paid by the company or another organisation will be subject to 20% VAT.
